Minutes

The meeting was brought to order at 4:30. Mary made a motion to approve the minutes. Doug seconded. Minutes were approved unanimously.

Guest - Ruby Moon

Ruby Moon, formerly affiliated with CBUF, reported that CBUF has sunsetted. As of August, it will no longer exist. Ruby would like to adopt the corner of Central Park at 8th and Monroe as a native plant garden, offering an opportunity for beautification and education, as well as raising awareness about native plants and trees. Parks and Rec is willing to supply native trees. There was a discussion about funding the project. Meredith said there are funds available to do this. Laurie asked if donations would come through Friends or go directly to Parks and Rec. Meredith said perhaps donations could go through Friends. Ruby added funds could also come from Adopt a Park. Laurie asked if the funds would be available for anyone who wants to adopt a park. Ruby suggested funds be raised and used for the NW corner of Madison Avenue/Central Park only. The funds from bulb sales (CBUF) could be used for this purpose. Ruby is also interested in becoming a Friends Board member. Olga will send her a Board application.

Treasurer's Report

Laurie reported that the account with Wells Fargo set up to sell donated stock is now ready to use. Meredith said that MLK Park's primary donor is ready to set up the next portion of his donation. Laurie said it can be sold immediately. Laurie thanked Mary for doing the research on this. Mary suggested that now, perhaps, more people will donate stock. Ruby pointed out that this is how Jackson Street Youth Shelter started. Olga made a motion to accept the Treasurer's report. Stephanie seconded the motion. Acceptance of the report was unanimous.

Saturday Market

Charley reported that a new banner with the new logo has been made. The big map of all Corvallis parks could not be found. People really like that map. Mary said people want a map the size of the bike trail map showing playgrounds in Corvallis. Charlie said there was one with the playground address and amenities at each location. He will talk to Julia Jacobs at Parks and Rec. Mary said folks at the booth need name tags.

C3 Programming

Lynne reported about a popular C3 program: Game Day on Thursdays. There are two pinochle groups. People from the Elks come to teach pinochle not only about the game, but about the friendships that develop when playing. Pinochle is thriving!

Olga asked if there are other games folks can play. Lynne said there is bridge in the fall, also cribbage, and board games. The program is free. Contact Meghan to make sure there is space for anything new.

Parks and Rec Update

Meredith reported that the Majestic was featured on cover of the National Parks and Recreation magazine, using a photo from the Tempest taken by photographer Sabrina Dedek.
